Course Overview

This undergraduate course serves as an introduction to the field of maternal and child health, focusing on major issues affecting the health and well-being of children and families over the life span. The course will emphasize health promotion, disease prevention, and supportive programs at different stages of a child's life. The course will also utilize the application of a Life Course Health Development framework to understand health disparities and implications for policy and practice.

HPM 140 is intended to give students a broad overview of the field of maternal and child health; the factors that determine the health status of mothers and children; important issues facing children and families in the U.S.; and an understanding of the child health service system (components and function); and how programs are designed to meet the needs of children and families.

At the end of this course, students should have knowledge and understanding of the following:

- 1. Historical development of maternal and child health practice
- 2. Life Course Health Development model
- 3. The importance of social determinants of health and illnesses
- 4. Selected issues for modern MCH populations
- 5. Characteristics of the current health care systems and implications for children

6. Basic principles and theories of population-based health promotion

In addition to the broad objectives above, students should be able to explore the design of maternal and child health programs and services and to evaluate the strengths and weaknesses of each. Students will be able to critically analyze disparities in health status based on race/ethnicity, socio-economic status, and gender; to identify essential gaps in existing maternal and child health programs; and to promote cultural competence concepts in diverse maternal and child health settings.

Course Requirements

Quiz:

There will be one quiz, worth 20%, on 1/28/21. The quiz will be distributed online via Qualtrics and consist of multiple-choice questions and a short answer question. Questions will focus on topics discussed in the lectures. The quiz link will be distributed on 1/28/21 and be open for a 24-hour period with 45 minutes total to complete it. No make-up exam will be given under any circumstances. Failure to take the exam during the scheduled class time will result in a score of zero for that exam.

Op-Ed Paper:

A personal op-ed paper with supplemental deliverable, worth 25%, will be due on 2/26/21 by 2 PM on CCLE. Any late papers will be subject to a 50% grade deduction. You have the option to work in pairs for this assignment and, if you choose to do so, will both receive the same grade.

Class Participation:

Class participation, reflecting an understanding of the course readings and lectures, is required and will make up 20% of your final grade. Participation will be measured by actively contributing during discussions with questions, comments, and reflections. Attendance will be taken at Zoom lectures. If you are unable to attend, please let us know and we can discuss how to approach your grade for participation.

Final Exam:

The in-class final exam will include the materials covered in lectures and the readings. The final exam is worth 35% of your final grade and will consist of multiple choice and short answer questions. Questions will focus on topics discussed in the lectures. No make-up exam will be given under any circumstances. Failure to take the exam during the scheduled class time will result in a score of zero for that exam.
